











Business News from the 2022 Annual Meeting

NAME and the NAME Foundation to Remain Separate 501c3 Corporations

Perhaps the biggest "news" as it relates to the Foundation is that the "merger issue" has been resolved. By a unanimous vote by both the Foundation Board of Trustees and the NAME Board of Directors, our two organizations will remain officially separate; however, both groups have pledged to work together towards the common goals that we share. A memorandum-ofunderstanding is being developed to ensure that the roles and responsibilities of each organization are more adequately addressed. A great big "thank you" to the NAME leadership, especially President Pinneri and Secretary-Treasurer Denton for all of their hard work at bringing this to a satisfactory resolution!





NAME Position on the Use of Pathology Assistants

Pathologists' Assistant's employment within the forensic pathology community has been a topic for discussion for decades in our community, but especially recently, as workforce shortages and higher caseloads have stressed medicolegal death investigation systems around the country. Members discussed the issue at the NAME Business Meeting on Monday morning at the Annual Meeting. Some background: NAME is working on a new Position Paper related to Pathologists' Assistants. There is a specific process by which such a paper is ultimately approved. One early step is to ensure that any proposed position paper does not conflict with current NAME standards. If NAME accepts its current form, the draft position paper document related to PAs would require several changes to be made within NAME's current Autopsy Standards. As such, the "business" addressed at this year's meeting was concerned with whether or not the proposed standard changes were acceptable to the NAME membership. As you may recall, the NAME Autopsy Standards are the "property" of the NAME membership. Therefore, only the membership as a group may officially change the Standards. After many minutes of vigorous debate, with many excellent points being


offered pro and con, the decision ultimately came down to a vote of the membership, wherein the suggested amendments to the Autopsy Standards to allow for PA participation in forensic autopsy performance were defeated by an approximately 70% to 30% margin.


